Sealed limited tenders are hereby invited on behalf of the Director, ICAR-Central Institute for Arid Horticulture, Bikaner for contract of PROVIDING JOB WORK/SERVICE CONTRACT FOR PROVIDING ALLIED SERVICES IN THE FARMER GUEST HOUSE SITUATED IN RESIDENTIAL QUARTER AND NEWLY CONSTRUCTED SCIENTIST HOME AT CIAH, BEECHWAL, BIKANER. The terms and conditions of the contract which will govern any contract made are those contained in the General conditions of contract applicable to the contracts and the special terms and conditions are detailed in the tender forms and its schedules. Please submit your rates in the limited tender form if you are in a position to furnish the requisite services in accordance with the requirements stated in the attached schedules.

- 2. An earnest money of Rs.10,000/-(Rupees Ten Thousand Only) must be deposited in the form of Demand Draft/Pay Order in favour of 'ICAR Unit CIAH, Bikaner". The particulars of the earnest money deposited must also be superscribed on the top of the envelope by indicating the draft/pay order number and date, failing which the limited tenders will not be opened. The limited tenders will not be considered if earnest money is not deposited with the tenders.
- 3. The tenderer is being permitted to give limited tender in consideration of the stipulation on his/her part that after submitting his/her limited tender, he/she will not refuse his/her offer or modify the terms and conditions thereof. If the tenderer fail to observe and comply with the foregoing stipulation, the Bid Security (Earnest Money) will be forfeited by the ICAR-CIAH. In the event of the offer made by the tenderer not being accepted, the amount of Bid Security (earnest money) deposited by the tenderer will be refunded to him/her after he/she has applied for the same, in the manner prescribed by the ICAR-CIAH.
- 4. The schedule of the limited tender form should be returned intact and pages should not be detached. In the event of the space provided on the schedule form being insufficient for the required purpose, additional pages may be added. Each additional page must be numbered consecutively and be signed in full by the tenderer. In such cases reference to the additional pages must be made in the limited tender form. If any modification of the schedule is considered necessary it should be communicated by means of a separate letter along-with the tender. Overwriting/erasing in rates to be quoted by the tenderer will not be allowed otherwise the tender may be rejected.
- 5. The limited tenders are liable to be ignored if complete information as required is not given therein or if the particulars asked for in the schedules to the tender is not fully filled in Individual signing the tender or other documents connected with the contract may specify whether he signs it in the capacity of (i) a sole proprietor of the firm or constituted attorney of such sole proprietor, or (ii) a partner of the firm if it be partnership in which case he/she must have

authority to refer to arbitration dispute concerning the business of the partnership whether by virtue of the partnership agreement or power of attorney or (iii) constituted attorney of the firm if it is a company.

- 6. If tenderer does not accept the offer, after issue of letter of award by Institute within 15 days, the offer made shall be deemed to be withdrawn without any notice & earnest money forfeited.
- 7. In case of partnership firms, where no authority has been given to any partner to execute the contract agreement concerning the business of the partnership, the limited tender and all other related documents must be signed by every partner of the firm. A person signing the limited tender form or any other documents forming part of the contract on behalf of another shall be deemed to warranty that he was authority to bind such other and if, on enquiry it appears that the persons so signing had no authority to do so, the ICAR-CIAH shall without prejudice to other civil and criminal remedies cancel the contract and hold the signatory liable for all cost and damages. Each page of the tenders and the schedule to the tenders and annexure, if any, should be signed by the tenderer.
- 8. The original copy of the Limited Tender is to be enclosed in double cover. The inner cover should be sealed. The outer cover should be sealed and super-scribed "THE JOB WORK CONTRACT FOR PROVIDING ALLIED SERVICES FOR PROVIDING JOB WORK FOR MAINTENANCE OF FARMER GUEST HOUSE SITUATED IN RESIDENTIAL QUARTER AND NEWLY CONSTRUCTED SCIENTIST HOME AT CIAH, BEECHWAL, BIKANER (RAJASTHAN)" with address of this office. All tenders should be sent by Registered Post. Limited Tenders to be hand delivered should be put in the tender box, which will be kept in the office not later than 14.10.2015 upto 01.00 P.M.
- 9. The rates quoted by each firm for job/service contract in limited tenders be given both in words and figures failing which the same is liable to be rejected. Tenderer is at liberty to be present or to authorize a representative to be present at the time of opening of the limited tenders. The name and address of the representative who would be attending the opening of the limited tenders on tenderer's behalf should be indicated in the limited tenders. Name and address of permanent representative of the tenderer if any, may also be indicated.
- 10. The Institute is not bound to accept the lowest or any other limited tenders and also reserve to itself the right of accepting the limited tenders in whole or in part. You are however at liberty to limited tenders for the whole or any portion or to state in the limited tenders that the rates quoted shall apply only if the limited Tenders are considered fully. Other conditional tenders will not be accepted.
- 11. An amount of equivalent to 10% of the total cost of the Job/Service Contract as a security deposit for the contract is to be deposited by the selected agency/successful tenderer only after receiving a communication from the Institute. In the event of non-deposition of the same the earnest money will be forfeited.
- 12. No interest on security deposit and earnest money deposit shall be paid by the Institute to the tenderer.
- 13. Service tax or any other tax applicable or made applicable after awarding the contract in respect of this job contract shall be payable by the contractor and ICAR-CIAH will not entertain any claim whatsoever in this respect. However the service tax or any other tax which is as per the rules of the Govt., shall be deducted at source from monthly bills of the successful tenderer, as per rules/instructions made applicable from time to time by Government.

- 14. Director, CIAH reserves the right to reduce or terminate the period of contract or to extend its duration in the interest of the ICAR-CIAH, for any justifiable reasons not mandatory to be communicated to the contracting agency.
- Decision of Director, ICAR-CIAH shall be final for any aspect of the contract and binding to all parties. Disputes arising, if any on the contract will be settled at his level by mutual consultation and in case of failure of settlement dispute shall be referred to the sole arbitrator to be appointed by the Director, ICAR-CIAH. The decision of the sole Arbitrator so appointed shall be final and binding on the parties. Arbitration proceedings shall be governed by the Arbitration & Constitution Act, 1996.
- 16. Acceptance by the ICAR-CIAH will be communicated by Speed Post/Fax/E-mail or any other form of communication. Formal letter of acceptance of the tender will be forwarded as soon as possible, but the earlier instructions in the Speed Post/Fax/E-mail etc. should be acted upon immediately.
- 17. The following documents/vouchers are required to be enclosed with the BID DOCUMENT which are as per the terms and conditions of the tender document. Incase required documents are not attached the bid is liable to be rejected.
 - a) Registration certificate of the firm under the work contract of the State Govt./Govt. of India.
 - b) Minimum turnover of the firm not less than Rs.5.00 Lakh (Rupess Five Lakh only) during the last financial year.
 - c) Last three years continuous experience of the firm in the field of providing such services in Central Govt. establishment/Autonomous bodies of Govt. of India/Corporation of Govt.of India/reputed public or private organizations. Provide the details in enclosed tabular form (Schedule-III)
 - d) Certified Balance Sheet of the firm for last year of the service contract by the chartered accountant.
 - e) Duly certified copies of the satisfactory services where the Tenderer is providing the services for the last three years.
 - f) Employee EPF registration certificate issued by local Govt. etc.
 - g) Employee ESI registration certificate issued by local Govt. etc.
 - h) The contractor agency must have a registration with the Contract Labour (Regulation and Abolition) Act, 1970. The contractor shall obtain the labour licence under this Act.
 - i) Nos. of staff/Supervisors registered under ESI & EPF separately. Minimum 50 Nos.(staff/Supervisors) required with the ESI & EPF contribution. Documentary proof of vouchers to be required and may be attached.
 - i) Service Tax registration certificate issued by Govt.etc.
 - k) Successful Tenderer will have to enter into a detailed contract agreement with ICAR-CIAH on appropriate value of non-judicial stamp paper of Rs.100/- (Rupees One Hundred Only).

GENERAL INFORMATION AND OTHER TERMS & CONDITIONS OF THE JOB WORK/SERVICE CONTRACT FOR PROVIDING ALLIED SERVICES FOR MAINTENANCE OF FARMER GUEST HOUSE SITUATED IN RESIDENTIAL QUARTER AND NEWLY CONSTRUCTED SCIENTIST HOME AT ICAR-CIAH, BEECHWAL, BIKANER (RAJASTHAN).

Scope of Work:

संस्थान के आवासीय में स्थित किसान अतिथि गृह व वैज्ञानिक गृह की देख-भाल हेत् वार्षिक जॉब कॉन्ट्रेक्ट अमुबंध की शर्ते :

- 1. The supporting/allied services staff should follow strict attendance Alternative arrangements are to be made by the agency whenever anyone of staff/supervisor happened to go on leave under intimation to this office.
- 2. Changing of staff/Supervisor should be intimated to Director, ICAR-CIAH, Bikaner.
- 3. The Director CIAH, Bikaner reserves the right to reject any or all tenders in whole or in part without assigning any reason therefore. The decision of Director, ICAR-CIAH, Bikaner shall be final and binding on the contractor/Agency in respect of clause covered under the contract.
- 4. The staff provided should also maintain secrecy and discipline in the premises of Institute.
- 5. The staff provided should be capable of reading and writing Hindi/English with a minimum qualification of Middle Standard.
- 6. The contractor shall keep a complaint register with his supervisor, and it shall be open to verification by the authorized officer of ICAR-CIAH for the purpose. All complaints should be immediately attended to by the Contractor.
- 7. The contract agreement is terminable with one month notice on either side.
- 8. The contractor/agency shall not sublet the work without prior written permission of the ICAR.
- 9. The contractor or his deployed workers shall not misuse the premises allotted to them for any purpose other than for which the contract is awarded.
- 10. The selected agency shall deploy the required personnel's for execution of job at ICAR-CIAH, as per labour acts. The agency shall employ good and reliable persons with robust health of age group of 21 to 45 years. In case any of the provided is not found suitable by the Institute the Institute shall have the right to ask for his replacement without giving any reason thereof and the agency shall on receipt of a written communication will have to replace such persons immediately.
- 11. The persons so provided by the agency under this contract will not be the employee of the Council and there will be no employer-employee relationship between the Council and the person so engaged by the contractor in the aforesaid services.
- 12. Payment for service contract will be made monthly upon submission of pre-receipted bill.

- 13. After physical inspection of the site, a very detailed assessment/requirements of personnel for providing allied services at the ICAR-CIAH, Bikaner shall have to be furnished alongwith the Tender, the Tender should indicate only the lump-sum amount in respect of all the services covered under this contract and that rates should not be proposed on the basis of manpower to be deployed under the contract. No request for alternation in the rates once quoted will be permitted within one year.
- 14. The rates to be quoted should include cost of each and every item including transportation cost, manpower and taxes etc. The CIAH/ICAR shall not bear any extra charge on any account whatsoever i.e. EPF contribution, Uniform, Liveries, OTA etc.
- 15. The Contractor will discharge all his legal & statutory obligations in respect of the workers/supervisors to be employed/deployed by him for the execution of the work in respect of their wages and service conditions and shall also comply with all the rules and regulations and provisions of law in force that may be applicable to them from time to time. The contractor shall indemnify and keep indemnified the Institute from any claims, loss or damages that may be caused to it on account of any failure to comply with the obligations under various laws. In case of any dispute, the decision of Director, ICAR-CIAH shall be final and binding on the contractor.
- 16. Income Tax will be deducted from the payments due for the work done as per rules.
- 17. They should not leave their points unless and untill the reliever comes for shift duties.
- 18. Changing of Supervisor/Staff should be intimated to the officer/person authorized by ICAR-CIAH.
- 19. The contract is subject to the condition that the tenderer will comply with all the laws and acts of Central Govt. and State Govt. of Rajasthan, relating to this contract made applicable from time to time.
- 20. Risk Clause: CIAH/ICAR reserves the right to discontinue the service at any time, if the services are found unsatisfactory by giving a show/cause to be replied within a week and also has the right to award the contract to any other agency at the risk and cost of current agency and excess expenditure incurred on account of this can be recovered from Security Deposit or pending bills or by raising a separate claim.

LIQUIDATED DAMAGES CLAUSE:

- 1. An amount equivalent to two days of contract amount, subject to a minimum of 10% of Bill Amount Per month will be levied as liquidated damages. Whenever and wherever it is found that the work is not up to the mark in any Section, it will be brought to the notice of the supervisory staff of the firm by ICAR-CIAH and if no action is taken within one hour liquidated damages clause will be invoked.
- 2. Any misconduct/misbehavior on the part of the manpower deployed by the agency will not be tolerated and such persons(s) will have to be replaced immediately.

The Director, ICAR-CIAH reserve the right to reject any or all Limited Tenders in whole or in part without assigning any reasons therefore. The decision of Director of the Institute shall be final and binding on the contractor/agency in respect of any clause covered under the Contract.
