#### Terms and Conditions for invitation of bids.

#### 1. Bid Security

Safeguard from bidders against withdrawal or alternation in bids during bid validity period, bid security must be obtained. Amount of bid security range 3% of estimated value of contract.

#### 2. Performance Security

To ensure specific performance of contract performance security must be obtained from successful bidder awarded the contract. Amount of performance range 3%. The exact amount of performance security should be determined and indicated in bid document. Performance security should remain valid for period of 60 days beyond date of completion of all statutory and contractual obligations of supplier. Bid security (Earnest money) will be refunded to successful bidder on receipt of performance security.

#### 3. Specimen Agreement

The Institutes will prepare agreement to be entered into with contractor/service Provider and get it vetted by any panel lawyers of the Institute. Agreement will be drawn with the successful tenderer. Tenderer shall quote his rates as per various terms and conditions of the said tender which will for part of the agreement.

#### 4. Evaluation of bids

Institute should evaluate, segregate rank responsive bids and select successful bidder for placement of contract. Bids received after specified date and time of receipt will not be considered.

#### 5. Liquidated damages

Contract should inter-alia mention amount that will be levied as liquidated damages. The amount will be decided by Director of the Institute and indicated in contract.

#### 6. Delivery Schedule

To be effected as early as possible but not later than 30 days. Any delay or inability to supply ordered stores may please be intimated immediately.

- 7. Rates must be quoted FOR destination at ICAR-CIAH, Bikaner-334006 (Rajasthan) including all charges and taxes.
- 8. The time allowed for supply of material and installation of drip system in the farm area one month from the date of issue supply and work order for installation of Drip system respectively. The last date for receipt of Limited Tender is 02.01.2023 at 5.00 PM. The received Limited Tenders will be opened on next working day i.e. 03.01.2023 at 11.00 AM.
- 9. Invite tenders are not acceptable through email or online.
- 10. No extension in time will be granted except on exceptional/justified grounds on written approval of the Director.
- 11. Income Tax @2%, TDS (GST) @2% and 1% Labour Cess will be deducted from the aggregate amount of the bill.
- 12. No deviation/compromise will be accepted of the item approved by the Committee to be supplied/fixed as per terms of contract.
- 13. We had read, understood and accepted all the terms and conditions mentioned in the Limited Tender/inviting letter.
